Ms. Frazier discussed the income statement as of September  $30^{th}$  and the cash balances as of November 30th. The District Audit is nearly complete; however, there are a few outstanding questions that need to be resolved before its completion.

Commissioner Orth moved and Commissioner Pleasant seconded to approve the Treasurer's report. The motion passed unanimously.

8. RECEIVE MONTHLY REPORT FROM THE TRAVIS COUNTY EMERGENCY SERVICES DISTRICT NO. 2 FIRE CHIEF REGARDING EMERGENCY MEDICAL SERVICES OPERATIONS, RESPONSE TIMES, CALL VOLUME, TRAINING, MANAGEMENT ACTIVITIES AND PERSONNEL;

Chief Perkins shared call volumes are up and congratulated the 5<sup>th</sup> ambulance placed in Station 6. He continues to see improvements on call processing times, but noted the delay is still on ambulances. The county provided funds to the city of Austin for additional providers, but questions remain on this program. He noted more C4 will be deployed across the district. He added they will get community paramedic services.
